More robust programming will require additional time based on complexity. These times are based upon a two week photo/video and documentation turnaround.

## How the system works.

### Data Collection

ACE collects logo's, photographs, video and documentation to be included. This information is loaded into our generic course templates. We will make the program look and feel like your Airport's using the information and graphics provided.

### Geo-specificity

Your airport users will take your Airports' geo- specific course and receive certification based upon successful completion of the mandated criteria. ACE understands that most airports are continually changing. With that in mind, minor changes to your SIDA and Drivers courses can be made quickly and in many cases *without additional cost*.

### Completion Criteria

Completion criteria can be modified within the system parameters to require a certain percentage score, completion of assignments if desired, and completion of any identified prerequisite courses. The system tracks when the user started the course, how long they spent on it, how many modules (if applicable) were completed and the results of testing.

### Certificate and User Security

Certificates are issued with unique security numbers. Forgery is eliminated, since your department has access to all certificates. Airport staff will have direct access to all student information making changes to employee data easy. Verification of actual users can be made and tracked to ascertain who is taking the course at that moment by answering security questions. Accounts can be suspended if student fraud is suspected.

### Recertification Notification

Notifications to users and supervisors can be automatically engaged to remind users of their need to recertify. This automated task alone can save hundreds of hours of work each year.

### Additional Airport Provided Training

Should your Airport have the in-house expertise, additional training programs and/or modifications to existing programs can be made without outside involvement or additional fees.
